6. Department Reports

- A. Administration: Tom Skjelstad, General Manager
- 1. DSPUD Facilities Plan September/October 2009- progress report from ECO:LOGIC for work performed on the facilities plan. In a memo from Jeff Hauser he reported that on September 25, ECO:LOGIC received the revised future EDU allowance for DSPUD (285 versus the previous 340). They then revised Technical Memorandum No. 1 (TM1) and provided the memo with the new design flows and loads to DSPUD on September 28. Establishment of these flows and loads allowed ECO:LOGIC to proceed with beginning the investigation of the biological treatment options.
- 2. Proposition 1A Securitization Program- a Statewide program designed to allow local agencies to receive 100% of property tax revenues which were borrowed by the State of California during the 2009/10 budget negotiations. Tom Skjelstad reported that in 2004 the California voters passed Proposition 1A to ensure that local property tax revenues and sales tax revenues remain with local government such as DSPUD. Prop. 1A can only be suspended if the Governor declares a fiscal necessity and two-thirds of the Legislator concur which occurred during the State's budget negotiations this past summer. This action resulted in the State temporarily borrowing 8% of all local agencies property tax revenue which is approximately \$8,000.00 per year for DSPUD.
- 3. Rising Cost of Water and Sewer Service Fees- an article in the October 2, 2009 edition of the Sacramento Bee. The town of Placerville is proposing a 66.7% increase to water service and a 122 percent to sewer service. Reported

- Chlorinated, cleaned and added approximately 2000lbs of anthracite coal to the pressure filter to improve filtering capacity.
